## Notice of organisational and personnel changes

We would like to announce the following organisational and personnel changes with effect from April 1, 2024.

- Organisational changes
- 1. A new Risk Management Office has been established to strengthen governance.

A new Risk Management Office has been established for the purpose of strengthening corporate governance functions and overseeing the management of governance and risk-related functions, with the aim of strengthening and expanding risk management across the group.

2. Newly established head office corporate divisions

The following departments will be set up to carry out highly specialised operations.

- (1) Establishment of a new IR office · · · to strengthen and expand IR activities
- (2) Establishment of a new System Operations Office • to facilitate the implementation of the SUNCORPORATION Group's overall system strategy and the execution of system operations
- 3. The Department of Corporate Strategy

This will be changed from an "Office" to a "Department" in order to strengthen and expand the role of corporate strategy.

In addition, the System Strategy Office will be established within the Department as an organisation specialising in system strategies, especially in DX.

4. Establishment of the Business Revitalisation Headquarters

The former Business Revitalisation Committee, which was established as an emergency response to the management crisis, will be progressively restructured.

5. Establishment of the Business Promotion Committee

The Business Promotion Committee will be responsible for promoting and managing the commercialisation of new products, while strengthening and promoting the management of sales expansion and profit growth.
